



GENERAL RULES AND REGULATIONS OF Mafia Inc.

1. LEGAL FRAMEWORK

1.1. DreamCentury Entertainment SARL is a French limited company with a capital stock of 137 204 Euros, located 7, rue Beaujon 75008 Paris, FRANCE, registered in Paris under the number B 434 076 899 (hereinafter collectively referred to as "the Organizer"). DreamCentury Entertainment edits the Game application "Mafia Inc.", an internet Game application, without obligation to purchase, available at the web address <https://facebook.mafiainc.com>, (hereafter referred to as "the Website").

1.2. The application Mafia Inc., and all the rights attached, are the exclusive property of the company DreamCentury Entertainment.

All trademarks, logos and other distinctive data shown on the Mafia Inc. application, including all websites which permit the access to the Mafia Inc. application through hypertext links, are the exclusive property of the company DreamCentury Entertainment and as such, are duly protected by the intellectual property code.

All use and/or non-authorized reproduction of these trademarks, logos and data are subject to legal sanctions and constitute a counterfeit.

1.3. All the software used and texts, commentaries, illustrations and pictures shown on the Mafia Inc. application, including all websites which permit the access to the Mafia Inc. application through hypertext links, are the exclusive property of the company DreamCentury Entertainment and as such, are duly protected by the intellectual property code.

All use and/or non-authorized reproduction of this software constitute a counterfeit and are subject to legal prosecution.

2. CONFIGURATION REQUIRED

2.1. Computer Configuration

The computer must permit at least a screen resolution of 1024 by 768 pixels with 65 536 colors.

2.2. Before starting to participate at Mafia Inc., we recommend the Player to close all other active applications for maximum resources in order to avoid problems during the execution of the Game.

3. LIMITATION OF LIABILITY OF THE ORGANIZER

3.1. The participation at the Mafia Inc. Game implies the knowledge and the acceptance of the characteristics and limitations of the Internet network, especially regarding technical performance, response times for consulting, querying or transferring information, the lack of protection of certain data against possible misappropriation, the risks of contamination and more generally inherent risks of any connection and transmission on the Internet, by possible viruses circulating on the network.

3.2. Accordingly, the Organizer shall not be held liable for the malfunction of one or several on-line services and/or the malfunction of the Game from a specific web browser.

The Organizer does not guarantee that the on-line services and/or the Game will function without interruption neither that they don't contain any computer errors nor that those bugs will be fixed.

In the event of a technical malfunction of Mafia Inc. for any reason or any cause, the Organizer reserves the right to invalidate and/or cancel the rounds played during the period in which this malfunction took place.

The Organizer reserves the right to automatically cancel all rounds of the Game played as long as one or several elements of the Game have shown a disproportionate expense or cost according to the normal function of the Game. As a result, the potential winnings will also be cancelled.

No claims whatsoever will be accepted.

3.3. The Organizer cannot be held liable if the data during the registration by a member were not correctly transmitted for any given reason (for example, network connection problem, a temporary failure of our system, etc...) .

The Organizer cannot be held liable if the data during the registration by a member are corrupted or impossible to process for any given reason (for example, if the Player owns a computer system, a software system or a mobile system inadequate for his registration).

3.4. The Organizer cannot be held liable for any prejudice of any kind (personal, physical, material, financial or other) that would occur during the Player's participation to the Games.

4. REGISTRATION REQUIREMENTS

4.1. Mafia Inc. is open to any person willing to participate, aged over 18 and above. By clicking the sign-up button, the Player confirms that he fulfills this requirement.

4.2. All people willing to participate at the Mafia Inc. Game must fill in an inscription form.

The Player is not allowed to own more than one account. Accounts may not be shared, transferred or otherwise used by more than one Player.

Employees, affiliates or partners of the Organizer, of its subsidiaries, its subcontractors or its officers, and the members of their Family or the persons with whom they are domiciled, and generally anyone who helped in the organization of the Mafia Inc. Game, are ineligible to participate in or win any Prizes on Mafia Inc.

4.3. A Player account is identified only on the sole basis of his e-mail address.

The last name, the first name, the gender, and the home address (zip code and country) are non-changeable data. The currency used upon registration of the Player is also non-modifiable.

4.4. The access to the Mafia Inc. Game is limited to a certain number of countries, the list of which is regularly updated. This list is displayed on the section: «Registration at Mafia Inc. Game».

4.5. For any registration made in violation of the Mafia Inc.'s "Official Rules and Terms of Service", especially when giving incorrect information such as registrations made under the same name, the Organizer reserves the right to suspend or terminate the account and permanently disqualify any Players and any prize or activity on DreamCentury websites.

The Organizer also reserves the right to cancel all the participations and winnings of a Player which registration form is not in accordance with the present Official Rules.

4.6. In order to have access to the Mafia Inc. application, the User must authorize its installation. The access to Mafia Inc. application is for an unlimited duration. However, the User is able to unsubscribe to the Mafia Inc. application at any time without any justification by removing the application.

5. PERSONAL REGISTRATION AND DATA

5.1. In accordance with the legal provisions in regards to personal data protection, especially the Article 34 of the French Act "Data Protection Act" of January 6, 1978, each Player acknowledges the fact that providing his personal data is required and is the sole condition to take his registration on Mafia Inc. into account. The lack of these data may forbid the Player to have access to Mafia Inc.

5.2. The personal Data are kept on-line up to the removal of the application and saved on a back-up medium during an additional period of five years in order to satisfy legal obligations.

5.3. The Players have the right to edit their personal information. They will be able to review, correct, update or remove information if appropriate.

5.4. The personal Data of the Players are exclusively used by the Organizer or, by potential Third-Party Companies developing, editing or exploiting the Game.

5.5. All the personal Data collected are used by the Organizer for the sole purpose of management and internal statistics. However, in accordance to the applicable law and rules, personal data might be communicated to a certified Third Party in case of a judicial or administrative requisition.

From time to time, The Organizer employs Third-Party contractors to collect personal information on our behalf to provide e-mail delivery, product, prize or promotional fulfillment, contest administration, credit card processing, shipping or other services on our sites. When requesting these services, you may be asked to supply your name, mailing address, telephone number and e-mail address to our contractors. We ask some Third-Party contractors, such as credit agencies, data analytics or market research firms, to supplement personal information that you provide to us for our own marketing and demographic studies, so that we can consistently improve our sites and related advertising to better meet our visitors' needs and preferences. To enrich our understanding of individual customers, we tie this information to the personal information you provide to us.

We may also access and disclose personal information, including personal communications, in connection with report abuse functions in our products and services, to enforce legal rights and comply with the law, or to comply with an order from a government entity or other competent authority, or when we have reason to believe that a disclosure is necessary to address potential or actual injury or interference with our rights, property, operations, users or others who may be harmed or may suffer loss or damage, or when we believe that disclosure is necessary to protect our rights, combat fraud and/or comply with a judicial proceeding, court order, or legal process served on the Organizer. Note that certain publically available information you post and communicate on our and Third-Party sites and services is public information for which you have no expectation of privacy.

5.6 Account Inactivity

An account is considered inactive if a player has not played at least 500 Free Games in the last 90 days. The organizing company reserves the right to block or delete any inactive account from its databases.

Any account that has not been accessed for a minimum period of one year, meaning no login using username and password, shall be automatically terminated. Such termination shall result in the definitive deletion of all points and winnings associated with the account, without any possibility of claim or compensation.

5.7 Any player questioning the integrity of the Organizing Company, its services, or its teams—based on the sole judgment of the customer service representative and their manager—will have their account blocked, with no possibility of complaint or compensation.

The Player is offered two options:

- Playing for free: the Free Mode
- Playing with charge: the Game Coins Mode

6.1. Playing For Free

The Player is credited with 30 free rounds daily which are automatically renewed each calendar day starting at midnight according to the time zone of the country entered upon registration on Mafia Inc. The free rounds, which haven't been used the day before, are completely lost.

Once the Player has used his 30 daily free rounds, he can obtain additional rounds thanks to the Facebook Sharing Meter (see article 8.3.2.2. Section "Community"). Unlike the daily free rounds, these extra rounds have no date limit.

6.2. Playing With Charge

The Player can get Game Coins by recharging his account through several means of payment: credit card, PayPal account, Surcharged Text Message, phone payment, bank wire transfer or by payment sponsored by our Partners' Offers.

7. REFUND POLICY

7.1. The Player may ask the Organizer to obtain the refunds of his participation through a simple written request sent by mail to the mailing address mentioned below. The following charges are refundable: fees paid when playing the Mafia inc. Game and costs related to postal charges when sending the refund request.

7.2. The refund of the cost of the rounds used through the Game Coins Mode is limited to the purchase to the 3 Game Coins per calendar month and per Player account.

In the limit mentioned above, the only refund requests that will be accepted are the ones which will be sent by post to the address mentioned below.

Any refund request for a Game Coins round must be sent not later than fifteen calendar days after the round has been done.

- Any refund request for a Game Coins round must be handwritten and must provide the following information :

- The photocopy of the phone bill or invoice highlighting that the Organizer has debited the Player's account with the amount of the paid fees, or any other notification proving that the payment has been made to the benefit of the Organizer. Any notification, even with the accurate payment must bear the full name of the Player's account. If not, the refund will be rejected with no possible recourse,
- The name of the Game on which the Player has played and for which he is asking the refund,
- The date and hour of the round played on Mafia Inc.,
- A Bank Statement,

7.3. Reimbursement Procedures

The refund amount is calculated as follows:

- According to the mean (s) of payment made to purchase the Game Coins used to play the specific round the User is asking for the refund, the User will be reimbursed on a pro rata basis.
- The fees paid by the User for the refund request will be refunded on the basis of delivery charges for ordinary mail according to the tariff in force. The Player must send a handwritten request letter, added to the refund request to the mailing address mentioned below:

Any refund request, which is incomplete and illegible with wrong, inaccurate and invalid personal info, sent beyond the authorized date, will be rejected and as a consequence, the Organizer will not respond to the request, with no possible recourse.

8. GAMES PRINCIPLES

To take part at Mafia Inc. Game, the Player must have validated his account. The virtual in-Game currency of Mafia Inc. are the MafiaDollars (Symbol : M\$ - a "M" followed by a "\$").

At the creation of his account the Player will have:

- A counter of free rounds,
- A Game Coins counter,

- A personal Safe where are automatically deposited the M\$ won during the Game rounds.

When a Player creates a Gang or is part of a Gang, the Player's account is directly connected to a joint Safe named "Gang Safe".

This Gang Safe belongs exclusively to the Gang and is increased with the M\$ won by each member of the Gang while playing her/his round.

Please note that there is a 2-minute time gap between the time the Player wins the M\$ and its' transfer into the Gang Safe.

8.1. The Game Grid

The Player has access to a Game Grid with 740 squares either in Free Mode or in Game Coins Mode. The Game Grid is the same for all Players, whether they play in Free Mode or in Game Coins Mode.

8.1.1. The Goal of the Game

The main objective of the Game, whether alone or with the Gang, is to find the Loot of the Game Grid which is a winning in Real Cash or in M\$.

The Player is able to know the content of each Game Grid by clicking on the button "Boxes of the Game Grid" on the home page of the Mafia inc. Game.

8.1.2. The Game Grid Boxes

Behind the boxes of the Game Grid are hidden the following prizes:

- MafiaDollars (M\$) Boxes,
- MafiaCards Boxes,
- Bonus and Penalty Boxes
- The Loot

8.1.2.1. The MafiaDollars

- The M\$ are hidden behind some Game Grid boxes.
- The M\$ boxes correspond to different values of M\$. They are worth 80 times as much in the Game Coins Mode.
- The Organizer reserves the right to modify the M\$ amount in the Grid boxes, at any moment.

8.1.2.2. The MafiaCards: The Collectible Cards

The MafiaCards are the fundamental part of an additional Game of the Mafia inc. Game. The goal is to collect cards in order to complete a MafiaCards Family. The Player wins M\$ or Cash Prizes in the currency of his country (see details in 8.2).

Like a real Mafioso you need to take risks and chances. But you must expect to find hurdles. As such, our Bonus/Penalty system helps you to con your way to the top !

The Bonuses found on the Mafia Inc. Game Grid are as follows:

- Racket :

- While playing in the Free Mode :
 - The Player gets 10% of the next uncovered Loot.
 - If the Player has already uncovered this Bonus in the current Game Grid, he gets a M\$ compensation.
- While playing with Game Coins :
 - The Player gets 25% of the next uncovered Loot.
 - If the Player has already uncovered this Bonus in the current Game Grid, he gets a M\$ compensation which is worth 80 times as much.

- Replay :

- While playing in the Free Mode:
 - The Player gets two additional free rounds with no date limit.
- While playing with Game Coins:
 - The Player gets two additional Game coins with no date limit.

- Clue :

- While playing in the Free Mode:
 - This Bonus gives the Player a hint on the location of the Loot: an area of 30 boxes at random are highlighted.
 - These highlighted boxes disappear once the page has been refreshed.
- While playing with Game Coins:
 - This Bonus gives the Player a hint on the location of the Loot: an area of 20 boxes at random are highlighted.
 - These highlighted boxes disappear once the page has been refreshed.

- Truce :

- While playing in the Free Mode :
 - The Player and all the Players, who played before the Player himself on this active Game Grid, win M\$ 40.
- While playing with Game Coins :
 - The Player and all the Players, who played before the Player himself on this active Game Grid, win M\$ 1600.

- Cosa Nostra:

- While playing in the Free Mode :
 - All the Gang Players (including the Player himself) are offered M\$ 100.
 - If the Player doesn't belong to a Gang, the Player wins a M\$ 200 compensation.
- While playing with Game Coins :
 - All the Gang Players (including the Player himself) are offered M\$ 1000.
 - The Player wins a M\$ compensation which is worth 80 times as much (multiplied by 80).

- Kick out :

The Kick Out Bonus is only valid if the Player who uncovers it is the Gang Boss. If the Player is not the Gang Boss, he wins a M\$ compensation.

- While playing in the Free Mode :
 - If the Player is not the Gang Boss, he wins M\$ 500.
 - If the Player doesn't belong to a Gang he gets M\$ 2 000.
- While playing with Game Coins :
 - If the Player is not the Gang Boss, he wins M\$ 40 000.
 - If the Player doesn't belong to a Gang he gets M\$ 160 000.

- Vendetta:

General Rules :

- This Bonus allows the Players of a Gang to attack another Gang's Safe. The Gang, victim of the Vendetta, is drawn at random among the Players who had uncovered an Ambush Penalty.
- The Player can't steal an amount exceeding the savings of his Gang's Safe.
- The stolen amount is a percentage of the Safe of the attacked Gang. This percentage is drawn at random.
- This Bonus is only valid if the Player is part of a Gang.

Exceptions:

- 1- **Retaliation required:** if the Player's Gang has been attacked the last four days :
 - a. The Player must fight back against the opposing Gang who has previously ripped off his/her Gang.
 - b. The Player automatically wins back the amount in M\$ which has been stolen from his/her Gang.
 - c. This rule applies only if the opposing Gang's Safe still contains enough M\$.

- 2- **Compensation:** if the Player can't attack any Gang or if he is not part of a Gang :
- a. The Player wins a M\$ compensation.

Free and Game Coins Mode:

- While playing in the Free Mode :
 - The stolen amount is randomly drawn between 5 to 15% of the Safe of the attacked Mafia Gang.
 - The Player gets a 1 000M\$ compensation.
- While playing with Game Coins :
 - The stolen amount is randomly drawn between 20 to 30% of the Safe of the attacked Gang.
 - The Player gets a 80 000 M\$ compensation which is worth 80 times as much.

- Boss:

This Bonus enables the Player to be the Gang Boss and run the Gang. If the Player doesn't want to or if the Player doesn't belong to a Gang, he wins a M\$ compensation.

- While playing in the Free Mode :
 - If the Player refuses the Boss Bonus, he gets M\$ 2000 in exchange.
 - The Player who doesn't belong to a Gang gets a M\$ 500 compensation.
- While playing with Game Coins :
 - If the Player refuses the Boss Bonus, he gets M\$ 80 000 in exchange.
 - The Player who doesn't belong to a Gang gets a M\$ compensation which is worth 80 times as much.

- Traitor:

With this Bonus, the Player can leave his Gang and is allowed to steal a share of his Gang's Safe.

While playing in the Free Mode:

- The share is randomly calculated with a 15% max.
- If the Player decided not to betray his Gang, he wins M\$ 2000 instead.
- The Player who doesn't belong to a Gang gets a M\$ 200 compensation.
- While playing with Game Coins :
 - The share is randomly calculated up to 30% max.
 - If the Player decided not to betray his Gang, he gets M\$ 80000 instead.
 - The Player who doesn't belong to a Gang gets a M\$ compensation which is worth 80 times as much.

The penalties found on the Mafia Inc. Game Grid are as follows:

Police:

This penalty mixes up all the remaining uncovered boxes of the Game Grid. Consequently, the information given with the Clue Bonus is no longer valid.

- While playing in the Free Mode :
 - The Player wins a 10 M\$ compensation.
- While playing with Game Coins :
 - The Player gets a 800 M\$ compensation which is worth 80 times as much.

- Ambush :

This penalty is valid only if the Player is part of a Gang.

When the Player uncovers this penalty, his Gang turns out to be vulnerable and can be attacked by another Gang on the sole condition that this opposing Gang uncovers the Vendetta Bonus.

- While playing in the Free Mode :
 - This threat on the Player's Gang is active for 72 hours starting from the date of the discovery of the Ambush penalty.
 - The Player wins a M\$ compensation.
- While playing with Game Coins :
 - This threat on the Player's Gang is active for 24 hours starting from the date of the discovery of the Ambush penalty.
 - The Player gets a M\$ compensation which is worth 80 times as much.

8.1.2.4. The Game Loot

- The Loot corresponds to a winning in M\$ or in Real Cash (in the currency of the Player) attributed according to a series of Loots priority generated which the maximum earning is the jackpot. In the Game Coins mode, the Loot value is worth 80 times as much.
- Once all the Loots of the current series are won, a new series is reset.
- Once the Loot has been uncovered, the Game Grid is refreshed and a new round begins.

8.2. The MafiaCards and the MafiaCards Family

- The MafiaCards are the fundamental part of an additional Game of the Mafia inc. Game.
- In the Free Mode, four MafiaCards Families (Spades, Hearts, Diamonds and Clubs) can be collected by the Player.

- In the Game Coins Mode, an additional MafiaCard Family is offered: the Trump Family. Once the Player has completed the whole Trump Family, he gets greater benefits.
- In the Free Mode :
 - while uncovering a MafiaCard box on the Game Grid, the Player wins a MafiaCard at random from the Spades, Hearts, Diamonds or Clubs Families.
- In the Game Coins Mode:
 - while uncovering a MafiaCard box on the Game Grid, the wins a MafiaCard at random from the Trump Family.
- All the MafiaCards collected are automatically added in her/his album, named Mafiabook.
- Once a MafiaCards Family is completed, the Player gets the winnings matching the Family. Then, all the Cards of the Family are set-up to zero, and a new Family is reset.
- The Player is also offered another option : he can sell his MafiaCards for M\$.

8.3. Gangs and Community

8.3.1. The Gangs

8.3.1.1. General Principles

- A Gang is composed of Players who team up together in a same group led by a Gang leader also named "Boss". A Player can either create his own Gang or join one.
- Each M\$ Prize, won on Mafia Inc. by the Player himself, is credited to his own Safe and 20% of his winnings are credited to his Gang's Safe.
- For example: a Player uncovers a M\$ 400 box. M\$ 400 will be credited to the Player's personal Safe and M\$80 will be credited to his Gang's Safe.

8.3.1.2. The Gang Leader Status or the Boss Status

- The Player who creates a Gang is automatically the Boss. A member can also become a Gang Boss while uncovering the Boss Bonus in the Game Grid.
- At the creation of the Gang, the Boss can accept or refuse the other members of his Gang to invite other Players to join the Gang.
- A Gang Boss cannot exclude a member of his Gang unless he uncovers the Kick Out Bonus.

8.3.1.3. The Safe Share Out

- At any time, the Gang Boss can decide to divide a part of the Gang Safe, in equal shares, and deposit it to the personal Safe of his Gang members according to the following rules:
 - Up to a maximum of 50% of the total amount of the Gang Safe,
 - A 7-calendar-day interval between two share outs.
 - With a minimum of M\$ 30000.

8.3.1.4. Closing a Gang

- A Gang is automatically closed when its last member decides to leave it.
- At any moment, the Player can leave his Gang but he has no rights whatsoever on the M\$ saved in the Gang's Safe he decides to leave.

- If the said Player is the current Gang Boss, the former Gang Boss is automatically selected to become the Boss. If this rule is not applicable, the oldest member of the Gang becomes the Boss.

8.3.2. The Community

8.3.2.1. The referral System

- The referral system rewards the Player for referring his friends to sign up on Mafia Inc. through his Facebook Profile. The Player can refer up to 30 friends.
- The Player earns M\$ according to the following :
 - For the 1st 10 referrals: M\$ 20000 per each referral,
 - From the 11th to the 20th referral included: M\$ 10000 per each referral
 - From the 21st to the 30th referral included: M\$ 10000 per each referral
- Mafia Inc. reserves the right to invalidate any suspicious referral.
The Player's account will be automatically blocked and without any possible recourse.

8.3.2.2. The General Principle of the Facebook Sharing Meter

- Each Player with a Facebook account can share information on his Facebook wall or his News Feed. Each click on one of the Gang Member's Share automatically increases the Sharing Meter of the Gang. The Player, who has originated the click, must log in to his Mafia Inc. account in order for the click to be taken into account.

- A raffle draw will be held at the end of the period mentioned in the section "Bet your M\$". If the raffle ticket of the Player is the winning one, he wins his M\$ back. If his raffle ticket is drawn out, he wins the Cash Prize and, as a result, won't be refunded.

11.2.3 The following information from the Player's PayPal account must match the Player's Mafia inc. account: country, email address, first and last name of the Player's PayPal account. The Player's PayPal account must be a "verified" PayPal account.

11.2.4 Transfer fees are covered by the Organizing Company. Fees related to a second international transfer, in cases where the foreign Player incorrectly entered their IBAN, are the responsibility of the Player.

13.1. Playing on Mafia Inc. implies a loyal and a good faith attitude in the absolute respect of the rules and the rights of the other Players. The Player assumes all responsibility and risk of the content which he provides and communicates to the Third Parties.

Through the content of his messages in whatever form, he is fully committed to not violate:

- The rights of the Third Parties (especially the intellectual or industrial rights such as trademarks, drawings, license, etc...)
- The existing laws and rules in his home country or in the country where the message is supposed to be sent,
- The rights of the players and by doing so not to send links that can affect an account or computer of Players within the Game.

15. FRAUD AND VIOLATION OF RULES

- include any offensive comments that are connected to race, national origin, gender, sexual preference or physical handicap;
- include profanity or any obscene, indecent, pornographic, sexual or otherwise objectionable content or language;
- defame, ridicule, mock, disparage, threaten, harass, intimidate or abuse anyone;
- promote violence or describe how to perform a violent act;
- send the staff abusing messages or bash them;
