

PRIVACY POLICY OF MAFIAINC.COM

1. Data Controller

All personal data that you provide at the time of registration, while browsing our Site, and/or when using our Services are managed by DreamCentury Entertainment. The processing of such data has been declared and registered with the CNIL (No. 1669793v0).

The purpose of the following privacy policy is to inform you about the collection, storage, and use of your information. This privacy policy only concerns the information you provide when using our services.

2. Personal Data

2.1 Collected Personal Data

When you use the Site (to register as a member and/or to use our free or paid services), we may ask you to provide data that personally identifies you.

"Personal Data" refers to all information you provide directly, particularly when you register on Mafia inc. to open an account or access the Services, or indirectly by browsing the Site.

The personal data collected on Mafia inc. concerns identification details provided during account registration by a user, including, but not limited to: last name, first name, username, title, age, gender, date of birth, address, phone number, email address, or other information from the social networks on which the User accesses Mafia inc., which are also subject to this privacy policy.

Providing some information may be optional. In all cases, we will only ask for the details strictly necessary for your registration on the Site, for its functioning, and to follow up on your orders. Whenever you provide us with such personal data, we will process it in accordance with the provisions of this Privacy Policy.

Electronic identification data allows us to indirectly recognize the user during their connections to the Site, such as, for example, their IP address or the pages visited on the Site. This data is not nominative and cannot, by itself, identify the user. Such anonymous usage data cannot identify you and is generally combined with your personal data. We typically use this usage data to provide you with better services and to personalize and enhance your experience on the Site.

Location data, such as the user's IP address or postal code, may indicate the geographic position of their connection terminal and is collected through cookies. This data allows the Company to provide geographically personalized Services related to a specific area.

The Company may therefore collect personal data when a user:

- opens an Account;
- uses Services;
- submits a complaint or a request for information;
- browses the Site, where cookies are stored on the user's computer or mobile device.

DreamCentury Entertainment will never attempt, without the user's consent, to obtain other information that could personally identify our users' profiles.

2.2 Personal Data Provided by Users

Each user is solely responsible for the data they provide. When inviting new members of their network or sending messages via the Mafia inc. application, DreamCentury Entertainment collects and securely stores the information related to these exchanges: email addresses and content.

The user agrees to:

- provide accurate and complete identification information and keep it regularly updated. If needed, the user can update this information at any time.
- choose a username and password that will allow them to access the Services.
- provide a valid contact email address.
- not use a username or email address that infringes on third-party rights, particularly rights to a name, trademarks, copyright, neighboring rights, or, more generally, anything contrary to current regulations, public order, or morality. Otherwise, the Company reserves the right to reject any names, terms, or expressions contrary to these principles, without being required to justify the decision.

The user may decide that other Service users can see certain personal data. In this case, the user is advised to provide only data they are comfortable sharing. We strongly recommend not providing any information that could be used to contact them directly.

2.3 Personal Data Collected from the User's "Facebook" Profile

The user is informed that DreamCentury Entertainment receives personal data from their "Facebook" profile, including their language, last name, first name, date of birth, country of residence, city of residence, email address, etc. In addition, DreamCentury Entertainment has access to the data you post on the "Facebook" social network. The Company reserves the right to update and store such data on its servers.

3. Purpose of Processing

We do not sell or rent personal data collected on the Site or on the "Facebook" social network to third parties. However, we may use collected personal data to ensure your effective use of the Site's Services, as well as for marketing, promotion, research, and analysis purposes.

In all marketing or promotional communications we send you, we will give you the opportunity to withdraw your consent to stop receiving such communications in the future.

Personal data may be used as follows:

- for account registration, maintenance, and authentication;
- to provide the Services available on the Site;
- to notify the User by email of new messages in their User account;
- to allow participation in satisfaction surveys or contests offered on the Site;
- to allow receipt of newsletters, commercial offers from the Company, its subsidiaries, or Partners (subject to the user's consent);
- to provide you with offers for products and services similar to the Service used;
- to generate anonymous statistics on Site usage;
- to evaluate and improve the quality of Services;

- to prevent any violation of the Terms of Use or Sale by the user or their affiliates, and to strengthen security measures;
- to ensure billing follow-up and accounting management of Services;
- to comply with applicable laws and regulations.

We reserve the right to monitor your account to check for any complaints or allegations of abuse, violation of third-party rights, or other unauthorized use of the Site.

4. Sharing of Personal Data with Third Parties

The user is informed that the Company may share personal data:

- with its technical providers for the hosting of said personal data, the registration and maintenance of
 Accounts, to help provide Services, and to manage customer relations. These technical providers are
 required to respect the confidentiality of personal data and are not allowed to use this data for any
 purpose other than the one for which the Company provides it to them;
- with authorized administrative authorities in cases of offense or violation of the Site Rules, or when the disclosure of Personal Data is required by law;
- with the Company's Partners.

We may collect and process data concerning your computer, including, where applicable, your IP address, operating system, and browser type, for system management purposes. This involves statistical data on user actions and browsing habits, which does not identify individuals.

However, we may link IP addresses to personal data (such as a user's country) and/or non-personal data (such as usage records or a user's access location) in order to enforce our Rules and, if necessary, prevent certain IP addresses from accessing all or part of the Site in the event of abusive use by the corresponding user.

5. Your Rights of Access, Modification, and Objection Regarding Your Personal Data

In accordance with applicable legislation, the user has the right to access, rectify, delete, and object to the processing of their Personal Data. They may exercise these rights by writing to:

place of birth to verify their identity. Users are reminded that they must update their identification information in case of changes to their situation.

On Mafia inc., you can also contact our customer service to request your unsubscription and the deletion of your data.

If the user no longer authorizes the Company to access their personal data available via the "Facebook" social network, they must uninstall the Company's application.

6. Retention Period of Personal Data

DreamCentury Entertainment keeps personal data for the time necessary to fulfill the purposes described above in the section "Purpose of Processing" and in accordance with CNIL recommendations, i.e., for three years from the end of the business relationship or, for prospects, from the time of data collection or the last

contact initiated by the prospect.

7. Protection of Your Personal Data

DreamCentury Entertainment uses industry-standard practices and implements strict security procedures to prevent any unauthorized access and to comply with applicable legislation on personal data protection.

However, since the transmission of information over telecommunications networks is not entirely secure, you acknowledge and accept that third parties may intercept the Personal Data you provide to us, and that such transmission is done at your own risk. Once your Data is received, we use strict procedures and security

mechanisms to try to prevent unauthorized access.

All personal data provided is stored on the Company's secure servers or those of its technical provider. The secure servers encrypt all personal data entered before it is sent to the Company. The servers of our

technical providers are located within the European Union.

The password that allows the user to log in to their account and use certain Services functions as protection for their personal data. The user is required to keep this password confidential and must never share or disclose it

to anyone.

The user is responsible for any use of the Site and associated Services by anyone using their account ID and password. The user must immediately contact DreamCentury Entertainment if they believe their account ID and password have been misused. As a precaution, the user is advised to log out of their account at the end of

each session.

You may check and modify the personal data we hold about you at any time through the Site or by contacting us via email or post.

8. Cookies

Cookies are files sent to the browser and stored on the computer's hard drive. They do not directly identify users visiting Mafia inc. However, they record information about the computer's browsing activity on Mafia inc. (pages visited, date and time of consultation, etc.), which Mafia inc. may read on subsequent visits. The computer retains an identification code in the cookie. The cookie only stores this identification code and no other personal information about the user.

Data collected through cookies is used in particular to improve the quality of the Site, making it more attractive or functional and easier to navigate.

Specifically, location data collected through cookies allows us to provide personalized Services.

The length of time this information is stored on the user's computer depends on the website(s) visited. After cookies are installed on their computer, the user may receive or see advertisements relating to products and services offered by the Company or its Partners. These ads are displayed under the sole responsibility of the Partners or advertising agencies.

DreamCentury Entertainment informs the user that they can refuse cookies by configuring their browser to warn them when cookies are sent to their computer, for example:

• For Mozilla Firefox:

- Choose the "Tools" menu then "Options"
- Click on the "Privacy" icon
- Locate the "Cookies" menu and select the desired options

For Microsoft Internet Explorer:

- o Choose the "Tools" menu then "Internet Options"
- Click on the "Privacy" tab
- Select the desired level using the slider

If the user has another Internet browser, they should consult that software's options to disable cookies. Generally, cookie deactivation is done in the software's options. The user should consult the help section of their browser for more information.

However, disabling cookies may prevent the user from accessing certain parts of the Site or using certain Services. Additionally, cookies from our partners may be placed on the website.

The user also acknowledges that when browsing on mobile Internet, certain mobile websites may install cookies on their mobile device. As with the website, these cookies record browsing information. The length of time this information is stored depends on the mobile website visited. After cookies are installed on their mobile device, the user may receive or see advertisements relating to products and services offered by the Company. These ads are displayed under the sole responsibility of the advertising agencies.
